As Aboriginal people from NSW we were the first colonised and the last recognised.

Our objective is to challenge this inequality.

We all need to stand together to do it. Stand with us.

Excerpts from the Rules of Boomalli Aboriginal Artists Co-operative Ltd:

9 Objects

The objects of the co-operative shall be:

- (a) To provide an Aboriginal Art Gallery for the display of Aboriginal Art and to provide exhibition space and support for Aboriginal and Torres Strait Islander artists.
- (b) To promote Aboriginal culture and independence through all visual art mediums.
- (c) To promote the teaching of arts and for self management and self determination.

20 Qualifications for Membership

- (a) A person is not qualified to be admitted to membership of the co-operative unless the board has reasonable grounds for believing that the person will be an active member under Rule 18;
- (b) Every member shall be of Aboriginal or Torres Strait Islander descent and be accepted as Aboriginal or Torres Strait Islander by the Aboriginal community in the local area;
- (c) Every member shall hold at least five shares;
- (d) Every member shall pay an annual membership subscription of \$22.00. The membership fee is to be paid by 30 September of each year;
- (e) EXCLUDED NOT REGISTERED
- (f) All members must be active members of the co-operative.

18 Active Membership Provision

- (a) The promotion and preservation of Aboriginal arts is a primary activity of the co-operative; and
- (b) a member shall during the previous twelve months have:
 - (i) kept a current curriculum vitae with the co-operative;
 - (ii) displayed a work of art in the co-operative's gallery, and
 - (iii) contributed a work of art free to the co-operative, to be used for the purposes of raising funds at an annual sale, in order to continue the work of the co-operative. The funds so raised shall be used at the discretion of the board, and
 - (iv) provided six completed works of art of exhibition standard to the society to provide a stock for exhibitions and sales arranged by or through the co-operative; in order to establish active membership of the co-operative.

Confirmation of Aboriginal Identity

Boomalli will be applying for funding for future exhibitions in which you may participate. The Australia Council requires confirmation of identity for some or all of the key artists:

- A letter/certificate confirming their Aboriginal or Torres Strait Islander identity provided by an organisation registered under the Corporations (Aboriginal and Torres Strait Islander) Act 2006 or other relevant legislation. This must be on letterhead and signed or stamped with a common seal; or
- A letter/certificate confirming their Aboriginal or Torres Strait Islander identity provided by an Aboriginal Land Council. This must be on letterhead and signed or stamped with a common seal.
